

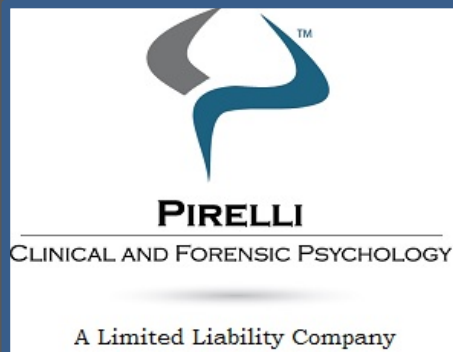

He conducts evaluations in a wide range of clinical and criminal, civil, and administrative matters. He is the Editor of the state journal, the *New Jersey Psychologist*, and he has taught over 40 postdoctoral, graduate, and undergraduate courses. Dr. Pirelli's research has been cited in amicus briefs to the U.S. Supreme Court and the New York Court of Appeals, and he has numerous publications, including the 2017 book, *The Ethical Practice of Forensic Psychology: A Casebook*, his new book: *The Behavioral Science of Firearms: A Mental Health Perspective on Guns, Suicide, and Violence* (2019), and the forthcoming book, *Guns and Clinical Practice: A Handbook for Medical and Mental Health Professionals – What to Know, Ask, and Do when Firearm-Related Issues Arise* – all with Oxford University Press.

In this **5-hour, 5 CE, in-person workshop**, Dr. Pirelli will address the present and emerging issues related to the intersection of firearms and mental health. It will include, but is not limited to a primer on guns, including their history, relevant statistics, gun safety principles, and relevant policies and laws – **including a review of NJ's newly amended duty to warn and protect reporting requirements**. Dr. Pirelli will also address issues related to guns and mental health, violence and domestic violence, and suicide as well as emerging roles of medical and mental health professionals in firearm-related matters, including those associated with evaluation, treatment, teaching, and research.

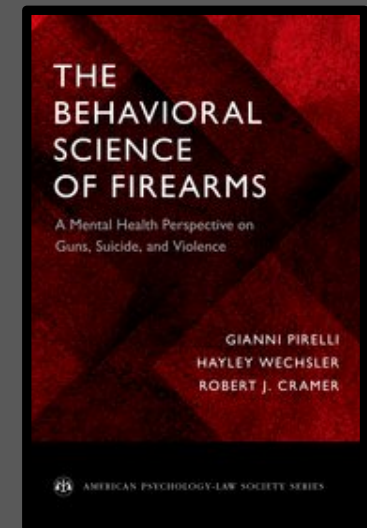
Learning Objectives: You will learn:
